### **The Mechanism:**

- **Control Subject Matter:**

- When filming involves use of any parking space (indicated by lines or other marks for the accommodation of one vehicle), a production company should apply to the Film Promotion and Facilitation Section for temporary suspension of the designation of the parking space. The application will be circulated to Transport Department, and other relevant Government departments where appropriate for comment.

- **Conditions to observe:**

- The film crew may be required to comply with the conditions imposed if there is no in-principle objection to the application from relevant Government departments. The Film Promotion and Facilitation Section will issue a letter to inform the applicant of the conditions to be complied with by the film crew.

### **How to Apply:**

- Parking Spaces (metered)
  - Complete an application form and submit it to the Film Promotion and Facilitation Section at least 5 working days in advance of the filming with the meter number of the metered parking space to be temporarily suspended .
- Parking Spaces (non-metered)
  - Complete an application form and submit it to the Film Promotion and Facilitation Section at least 5 working days in advance of the filming with a sketch map indicating the non-metered parking space (shown hatched black) to be temporarily suspended.

**Application Fees:** Nil

**Duration of the Suspension:** As stated in the reply letter
